Rob called the meeting to order. He asked for volunteers to say the prayer, Steve Clarke volunteered and said the prayer. Rob asked for a volunteer to say the pledge, their was no response, Rob Dotson led the group in the Pledge.

Rob explained the 4 goals that he has discussed in his article in the newsletter. He announced that at our next meeting we would have a presentation by Scott Neal from new Horizon engineering showing plans for an Old Spanish Trails museum. He is preparing these plans free of charge. Rob also has arranged for John at Bulloch Brothers Studios to do the front design. John will also do the scoping for a National Parks and Trails grant from the Federal Government. Discussions were had concerning volunteers to help run booths, making presentations, food and campfire programs. Assignments were made. Mr. Matheson will make Historical Presentations, Jeff and Susan Lewis will be over food with either booths of Spanish style food, and or Dutch oven cooking. Steve Clarke was assigned to check with the Mountain Men Rendezvous to see if we can get them involved. Gerald Van Iwaarden will talk to the Priest at Christ and the Paiute Indian Tribe to see if this date is good for them and we can get them involved. Mr. Ford will talk to the Cold Creek Cowboys to see if they are available and could maybe have a shooting booth, or stage some time of a Lagoon type wild west shoot-out. All these people will report their findings at the next meeting.

Field trips were discussed. Colonel Matheson complimented Blaine Nay on his work with the web site. Mr. Matheson discussed several possible field trip locations with how cold it has been perhaps we could take a trip to the Thermal Hot Springs. He also shared maps and locations of some of the findings of the Old Spanish Trail. He proposed securing some land for a park, and told of some local expansion being experienced in Iron County.

It was decided that no field trips would be taken in January, and we planned to have a slide show of places and traces along the Old Spanish Trail instead of an actual field trip for the Month of February.
