Firearms Safety Course Student Agreement

1 - The fundamental NRA rules for safe gun handling are:

- Always keep the gun pointed in a safe direction.
- Always keep your finger off the trigger until ready to shoot.
- Always keep the gun unloaded until ready to use.
- Know your target and what is beyond.
- Know how to use the gun safely.
- Be sure the gun is safe to operate.
- Use only the correct ammunition for your gun.
- Wear eye and ear protection as appropriate.
- Never use alcohol or over-the-counter, prescription or other drugs before or while shooting.
- Store guns so they are not accessible to unauthorized persons.
- Be aware that certain types of guns and many shooting activities require additional safety precautions.

2 - Federal and Utah State laws prohibit certain persons from possessing firearms and ammunition.

Restricted persons include:

- Persons who have been convicted of a felony.
- Persons who have been convicted of a crime of violence.
- Persons who have been convicted of an offense involving the use of alcohol (ie DUI/DWI, alcohol related reckless, supply alcohol to minor, etc).
- Persons who have been convicted of the unlawful use of narcotics or other controlled substances.
- Persons who have been convicted of any offense involving moral turpitude (ie, theft, criminal mischief, sex crimes, etc).
- Persons who have been arrested for any offense involving domestic violence.
- Persons who have been adjudicated as mentally incompetent.
- Persons who have been involved in any incident in which they used unlawful violence or threats of unlawful violence.
- Persons who are currently subject to a court-sanctioned protective order.
- Persons who have been dishonorably discharged from the armed forces.

I understand that this training presents general information regarding firearm safety, self-defense, and the law and that it is not intended to be comprehensive in any way nor is it intended as legal advice. I understand that the laws governing firearm ownership, possession, and self-defense are subject to frequent changes through legislation and court interpretation and that nothing in this course shall be taken as a definitive guide to the laws in my jurisdiction. For any legal questions, interpretations or advice, I will consult with a knowledgeable attorney.

I understand that the training staff may provide firearms and ammunition for student use. I understand that the provided ammunition may be remanufactured or reloaded – not factory new but that the training staff takes reasonable care to ensure that provided firearms and ammunition are safe to use. I understand that I am not required to use staff-provided firearms and ammunition and that I am welcome to provide my own and will be responsible for the safe condition of any firearms and ammunition I provide.

I understand that my instruction may be terminated at any time, and my fee forfeited, if my cooperation is deemed to be unsatisfactory by the instructors or if my behavior or actions are deemed to be a risk to others or myself or if, in the opinion of the instructors, I fail to demonstrate the proper attitude and knowledge necessary for the safe and proper use of firearms.

I hereby release the National Rifle Association (NRA) and Three-Peaks Gun Safety, their officers, directors, instructors, agents and employees, and those other organizations affiliated with this course from any liability, loss, damage, costs, claims and/or causes of action, including but not listed to all bodily and personal injuries and death and property damage, arising out of my participation in firearms training courses taught by Three-Peaks Gun Safety, it being specifically understood that said course includes the operation and use by the undersigned and others of firearms and ammunition. This release is given on behalf of my heirs, successors, executors, administrators, assigns and myself.

I understand that there are inherent and other risks involved in the use of firearms and ammunition in shooting and I freely and voluntarily assume and accept those risks. I understand that serious injury or property damage can be sustained if these safety practices are not strictly adhered to. I understand that the safe and proper use of firearms requires a positive attitude based on maturity, responsibility, ethics and respect. I will comply with all the safety rules given in paragraph 1 above and will follow the safety directions of the training staff. I accept full responsibility for the consequences should any injury or damage be caused by my failure to practice these safety rules.

I certify that I am not restricted from handling or possessing firearms as described in paragraph 2 above.

The applicable laws of the State of Utah govern this agreement. If any part of this agreement is determined to be unenforceable, all other parts shall be given full force and effect.
